

LINKME MARKETING PARTNER AGREEMENT

We are pleased to invite you to participate in the LinkMe brand Marketing Partner Program. The goal of this program is to allow us to partner with selected companies that we believe can effectively collaborate with us to promote the LinkMe brand and our innovative online service offerings in a rapidly growing global marketplace. We look forward to working with you.

Authorized Partner. By entering into this agreement, you will become an authorized LinkMe brand marketing partner with the opportunity to earn fees by referring prospective customers to us or by registering and creating shop and services for service professionals.

Opportunity Registration. To be eligible for a partner fee on an opportunity you have identified, simply start by filling out the paper registration form and then register the user on the LinkMe.ng Portal before commencing the creation of shop and services for the registered user. We may also identify a prospective user that we believe you would be well situated to pursue and, in those cases, link those users to you. An opportunity/shop registered by you that we approve in the portal is an "Approved Opportunity."

Partner Fee. Your partner fee can be up to **ten percent (10%)** of the subscribed featured and subscription plan of a registered shop fees payable in the first year by the user in connection with the Approved Opportunity. We will designate a partner fee rate for each Approved Opportunity in the LinkMe.ng Portal taking into account your efforts and activities in support of the closed transaction. Below are some examples:

- ❖ *Approved Opportunity:* A partner fee of up to **#50.00** would be typical for a transaction where you register a user and then go on to create a service shop with services for the user to the point of getting a shop approval. An example of this type of opportunity would be one where you have a user registered with the evidence of paper registration which should have the same records as on the linkme.ng portal.
- ❖ *Featured Opportunity:* A partner fee of up to **ten percent (10%)** would be typical for a transaction where you register a user, create a service shop with services for the user to the point of getting approval and then have the shop featured on the homepage of the linkme.ng portal.
- ❖ *Subscription Opportunity:* A partner fee of up to **eight percent (8%)** would be typical for a transaction where you register a user, create a service shop with services for the user to the point of getting approval and then have the shop activated for a subscription based user on the linkMe.ng portal.

Paper Registration Form: The Paper registration form now helps us to facilitate and manage our partner relationships. The paper form would be supplied to you by the Linkme.ng team and you will need to fill in all required fields for each of your registered opportunities and keep them updated, in each case promptly and accurately. This paper form will serve as the system of record for the status of your



registered opportunities as well as all activity and other information relating to your registered opportunities for purposes of this agreement, including whether an opportunity is an Approved Opportunity and the partner fee rate applicable to an Approved Opportunity.

Services. You may request consulting or education services from us by submitting a formal request to the LinkMe.ng team.

Duration. This partnership shall last for a period of one(1) year from the date of the execution, after which it may be renewed.

Term and Termination. You may terminate this agreement at any time by providing written notice to us. We may terminate this agreement upon written notice to you (1) If it is noticed that you willfully supply wrong information in registering a user or you register fake users and shops (2) If you breach a material provision of this agreement and fail to cure the breach within thirty (30) days following such notice; or (3) at any time upon written notice to you following the one-year period beginning on the date of execution of this agreement.

Marketing. We have the right to issue a mutually-agreed press release that includes a quotation from you or one of your senior executives. You may also issue a press release with our prior review and approval. Each party grants the other the right to use its name and logo in public communications, on websites, in presentations, in marketing collateral and at marketing events.
